A. Background: In order for the Medicare Fee-for-Service program to correctly and accurately edit the inbound Accredited Standards Committee (ASC) X12 version 5010 837 Institutional, 837 Professional claims, and the 276 Claim Status Inquiry, several code set updates are required. These are common code sets that are used across both the Part A and Part B CEMs and are updated on a regular basis.

B. Policy: Health Insurance Reform: Modifications to the Health Insurance Portability and Accountability Act (HIPAA): Final Rules published in the Federal Register on January 16, 2009, by the Department of Health and Human Services at 45 CFR Part 162.
